
RE: Doncaster Pole Line/Right of Way

MOHAWK COUNCIL RESOLUTION NO. 05/1985-86

PROPOSED BY: Chief Eugene Montour

SECONDED BY: Chief Ida Goodleaf

WHEREAS Hydro-Québec and/or it's predecessors were in need of a right-of-way for a pole line distribution through the Mohawk Doncaster Territories of Kahnawake and Kanesatake;

WHEREAS the Mohawks of Kahnawake and Kanesatake did agree by resolutions dated September 9, 1972 and October 30, 1972 to give a right-of-way on such lands in exchange for monetary values to Hydro-Quebec for a period of time from July 15, 1964 to July 14, 1982, thereby giving the Department of Indian Affairs the authority to sign for such right-of-way on November 22, 1973;

WHEREAS a renewal to the right-of-way has been sought after by the Kahnawake and Kanesatake Mohawks for the period after July 14, 1982 without success or any positive development;

THEREFORE BE IT RESOLVED THAT the Mohawks of Kahnawake and Kanesatake do hereby give Hydro-Quebec up until noontime August 30, 1985 to remove all poles and lines on the Doncaster Territories; and, if this directive is not adhered to, such pole line will then be removed by the Mohawks of Kahnawake and Kanesatake.
